Visa Free countries

Nationals of **Nepal** and **Bhutan** do not require visa to enter India. However, Nepali nationals require visa if they enter India from China, which normally granted gratis.

Visa Fee for Pakistani Nationals

The fee for Pakistan nationals is COP 15.000/USD 4 for all type of visas.

Visa Fee for Singaporean Nationals

The fee for Tourist visa, up to six months in respect of Singapore nationals will be is **COP 105.000/USD 28**.
