- 5. The firm would be responsible for its worker in terms of his clean antecedents and conduct, service performance & behaviour, payment of salaries, compensation etc.
- 6. The Embassy of India will not be responsible for any dues other than the agreed contract amount. The gardener shall not have any claim for regularization of his services or enhancement of wages with the Embassy of India. Sworn affidavits to these effects from the workers deployed on the premises by the company will have to be furnished.
- 7. Contract amount, once agreed to by the firm, will not be increased during the period of the contract.
- 8. The tender document will be required to submit a certified cheque for Colombian Pesos 20,000 (**non-refundable**) payable to "The Embassy of India, Bogota."

- 9. Bidder would be required to furnish the information and submit documents, as per attached Technical Bid.
- 10. Prices quoted (strictly on monthly basis only) should be given in the attached Financial Bid.
- 11. The bidding firm will have to submit 'Technical Bid' along with 'Financial Bid'. Financial bids of only technically qualified bidders would be opened to award the contract.
- 12. A Bid shall be treated as successful only after the competent authority of the Government of India has approved it in accordance with the terms of the Tender Notice. The Embassy of India shall send the notice to acceptance of the successful lowest Bidder. Subsequent to the notice, a contract shall be signed between the Embassy of India and the successful lowest Bidder.
- 13. The Embassy of India reserves the right to revoke the contract at any time if the services rendered are not found satisfactory during the period of contract.
- 14. The Embassy of India shall also have the right to impose such penalty as it deems fit on the firm if the Embassy of India is put to any financial loss directly or indirectly by any act of omission or commission on the part of the firm or the person deployed by it on the premises of the Ambassador.
